NAME OF ASSOCIATION

The name of the Association is **Western Dressage Association of Australia (Inc)**.

PART 1 - PRELIMINARY

1. Terms Used

In these rules, unless the contrary intention appears —

Act means the *Associations Incorporation Act 2015*;

Affiliate means an incorporated association or a branch, which is a member or is otherwise affiliated with the Association

associate member means a member with the rights referred to in rule 9 1.(b);

Association means the incorporated association to which these rules apply;

board means body consisting of the committee members who are the management committee of the Association;

board meeting means a meeting of the board;

board member means a member of the board;

books, of the Association, includes the following —

- (a) a register;
- (b) financial records, financial statements or financial reports, however compiled, recorded or stored;
- (c) a document;
- (d) any other record of information;

by laws means by-laws made by the Association under rule 66;

chairperson means the Committee member holding office as the chairperson of the Association;

Commissioner means the person for the time being designated as the Commissioner under section 153 of the Act;

committee means the management committee of the Association

committee meeting means a meeting of the committee

committee member means a member of the committee

Constitution means the Constitution (Rules) of the Association

financial records includes —

- (a) invoices, receipts, orders for the payment of money, bills of exchange, cheques, promissory notes and vouchers; and
- (b) documents of prime entry; and
- (c) working papers and other documents needed to explain —
 - (i) the methods by which financial statements are prepared; and
 - (ii) adjustments to be made in preparing financial statements;

financial report, of a tier 2 association or a tier 3 association, has the meaning given in section 63 of the Act;

financial statements means the financial statements in relation to the Association required under Part 5 Division 3 of the Act;

financial year, of the Association, has the meaning given in rule 2;

general meeting, of the Association, means a meeting of the Association that all members are entitled to receive notice of and to attend;

member means a person who is an ordinary member or an associate member of the Association;

office holder means the holder of one of these committee positions – chairperson, deputy chairperson, secretary, treasurer.

ordinary committee member means a committee member who is not an office holder of the Association under rule 28(3);

ordinary member means a member with the rights referred to in rule 9(1) & 9(2);

register of members means the register of members referred to in section 53 of the Act;

rules means these rules of the Association, as in force for the time being;

secretary means the committee member holding office as the secretary of the Association;

special general meeting means a general meeting of the Association other than the annual general meeting;

special resolution means a resolution passed by the members at a general meeting in accordance with section 51 of the Act;

subcommittee means a subcommittee appointed by the committee under rule 50 1.(a);

tier 1 association means an incorporated association to which section 64(1) of the Act applies;

tier 2 association means an incorporated association to which section 64(2) of the Act applies;

tier 3 association means an incorporated association to which section 64(3) of the Act applies;

treasurer means the committee member holding office as the treasurer of the Association.

2. Financial Year

1. The first financial year of the Association is to be the period not exceeding 15 months fixed by the Board, being a period commencing on the date of incorporation of the Association and ending on 30 June.
2. Each subsequent financial year of the Association is the period commencing 1 July and ending on 30 June in the following year;

3. The Objects Of The Association Are:

1.
 - (a) Create in conjunction with Affiliates a uniform entity through and by which Western Dressage can be encouraged, conducted, promoted and administered and to be the governing body of Western Dressage in Australia;
 - (b) Develop, implement and maintain an Australian rulebook that is appropriate to Australia as a whole.
 - (c) Promulgate and secure uniformity in such rules and standards as may be necessary for the management of Western Dressage competitions and related activities, including but not limited to the rules of Western Dressage and coaching and officiating standards;
 - (d) Formulate and implement appropriate policies, including policies in relation to member protection, risk, codes of conduct, health, safety, youth and senior programs, horse welfare, and such other matters that arise from time to time as issues to be addressed in Western Dressage;
 - (e) Establish and conduct education and training programs for riders, coaches, judges and officials in the implementation and interpretation of Western Dressage rules and standards;
 - (f) In conjunction with Affiliates further develop the Association and Western Dressage into an organised institution having regard to these Objects;
 - (g) Maintain a point score system for an awards and recognition program, including State & National end of year awards; gained by competitors at approved Western Dressage Association of Australia Incorporated competitions.
 - (h) Give recognition to successful members, officials and other individuals participating in Western Dressage and issue appropriate awards;
 - (i) Act as arbiter (as required) on all matters pertaining to the conduct of Western Dressage in Australia, including disciplinary matters;
 - (j) Pursue such commercial arrangements, including sponsorship and marketing opportunities as are appropriate to further the interests of the Association
 - (k) Represent the interests of its Members and the Association generally in any appropriate forum in Australia and Internationally.
2. The property and income of the Association shall be applied solely towards the promotion of the objects of the Association and no part of that property or income may be paid or

otherwise distributed, directly or indirectly, to members, except in good faith in the promotion of those objects.

PART 2 – ASSOCIATION TO BE NOT FOR PROFIT BODY

4. Not-For-Profit Body

1. The property and income of the Association must be applied solely towards the promotion of the objects or purposes of the Association and no part of that property or income may be paid or otherwise distributed, directly or indirectly, to any member, except in good faith in the promotion of those objects or purposes.
2. A payment may be made to a member out of the funds of the Association only if it is authorised under subrule (3).
3. A payment to a member out of the funds of the Association is authorised if it is —
 - (a) the payment in good faith to the member as reasonable remuneration for any services provided to the Association, or for goods supplied to the Association, in the ordinary course of business; or
 - (b) the payment of interest, on money borrowed by the Association from the member, at a rate not greater than the cash rate published from time to time by the Reserve Bank of Australia; or
 - (c) the payment of reasonable rent to the member for premises leased by the member to the Association; or
 - (d) the reimbursement of reasonable expenses properly incurred by the member on behalf of the Association.

PART 3 – MEMBERS

In accordance with sections 4 and 17 of the Act, the Association must always have at least 6 members with full voting rights.

Division 1 - Membership

5. Eligibility For Membership

1. Any person who supports the objects and purposes of the Association is eligible to apply to become a member.
2. An individual who has not reached the age of 19 years is not eligible to apply for a class of membership that confers full voting rights.

6. Applying For Membership

1. A person who wants to become a member must apply in writing to the Association.
2. The applicant must specify in the application the class of membership, if there is more than one, to which the application relates.

7. Dealing With Membership Applications

1. The committee must consider each application for membership of the Association and decide whether to accept or reject the application.

2. Subject to subrule (3), the committee must consider applications in the order in which they are received by the Association.
3. The committee may delay its consideration of an application if the committee considers that any matter relating to the application needs to be clarified by the applicant or that the applicant needs to provide further information in support of the application.
4. The committee must not accept an application unless the applicant —
 - (a) is eligible under rule 6; and
 - (b) has applied under rule 7.
5. is eligible under rule 6; and
 - a) has applied under rule 7.
6. The committee must notify the applicant of the committee's decision to accept or reject the application as soon as practicable after making the decision.
7. If the committee rejects the application, the committee is not required to give the applicant its reasons for doing so.

8. Becoming A Member

An applicant for membership of the Association becomes a member when –

- (a) The committee accepts the application; and
- (b) The applicant pays any membership fees payable to the association under rule 14.

9. Classes Of Membership

1. The Association consists of ordinary members of the following classes.
 - (a) Senior Members - who may compete in all levels of competition and have the right to be present, speak and vote at General Meetings and to serve in a position as a committee office holder or committee member.
 - (b) Associate Members - who have the right to be present and speak at General Meetings but not to cast a *vote* at General Meetings. They are not able to take part as a rider in any ridden events, nor are they eligible to become a judge.
 - (c) Youth members-, who must be eighteen (18) years or less in the membership year shall have the right to enter competition deemed open to a youth rider, but not to cast a vote at General Meetings, nor be able to serve as a member of the committee except a sub-committee to represent Youth Members.
 - (d) Affiliate Members - who are incorporated bodies which, subject to this Constitution, shall be represented by their Delegate who shall have the right to be present, speak and vote at General Meetings only.
 - (e) Life Members - who may compete in all levels of competition and have the right to be present, speak and vote at General Meetings and to serve in a position as a committee office holder or committee member.
 - (f) Honorary Life Member - who are elected by a General Meeting to that position and by virtue of that election becomes entitled to exercise all the rights of a Senior Member are in perpetuity, but are not required, to pay for or renew his or her membership.
2. Additional member classes.

The committee may from time to time, either in its own right, or upon recommendation from

members, create new classes of membership with such rights, privileges and obligations as are determined applicable, even if the effect of creating a new class is to alter rights, privileges or obligations of an existing class of members. Further the committee has the right to amend membership classes and their rights, including the removal of membership categories as deemed appropriate within the Objects.

10. Affiliate Membership Responsibilities

1. Each Affiliate shall:

- (a) be and remain incorporated;
- (b) be and remain a body that is not carried on for profit and which is exempt (or entitled to be exempt) from income tax;
- (c) will upon request, provide Western Dressage Association of Australia Incorporated with copies of its annual financial statements, annual report and associated documents of the affiliate's annual general meeting;
- (d) co-operate with any audits as deemed necessary by the committee to support Western Dressage Association of Australia Incorporated governance and standards.
- (e) adopt in principle the Objects and Rules in its Constitution which are, to the extent permitted or required by the State Acts, generally in conformity with this Constitution and give effect to those Objects and Rules as so adopted;
- (f) apply its property and capacity solely in pursuit of the Objects and the promotion of the Affiliate and Western Dressage;
- (g) maintain in a form and with such details as are reasonably acceptable to the Association, a register of all its members by whatever name or description and a register of all horses proposed for registration by any of those members. Each Affiliate shall provide an updated copy of the register at a time and in a form reasonably required by the Association and will permit the Association to inspect the register during usual office hours;
- (h) not do anything that would preclude the Association from meeting the Objects;
- (i) encourage, promote and administer Western Dressage in its region / territory consistent with the intent expressed in this Constitution and its Constitution so as to create uniformity in the way in which the Objects and Western Dressage are to be conducted throughout Australia.

2. Mutual Agreements

Western Dressage Association of Australia Incorporated and each of the Affiliates agree with the others of them:

- (a) to act in good faith and loyalty to each other to ensure the maintenance and enhancement of Western Dressage, its standards, quality and reputation for the collective and mutual benefit of them and their respective members, including in their capacity as participating Members,
- (b) not to do or permit any act or thing which might be reasonably considered to adversely affect or derogate from the generally accepted standards, quality and reputation of Western Dressage in Australia, and its maintenance and enhancement;
- (c) to make full and proper disclosure, in the case of the Association, to each of the Affiliates and in the case of an Affiliate to the Association and Affiliates, of any Matter of Importance of which it is aware. Western Dressage Association of Australia Incorporated shall not be obliged to disclose confidential information received by it on a confidential basis, including information from an Affiliate, or if precluded by law from

doing so but otherwise shall do as much as it reasonably can to make full disclosure to the Affiliate. In this paragraph "Matter of Importance" means a matter which would reasonably be considered to have a material and adverse or prejudicial impact upon any of them or Western Dressage in Australia.

11. When Membership Ceases

1. A person ceases to be a member when any of the following takes place —
 - (a) for a member who is an individual, the individual dies;
 - (b) for a member who is a body corporate, the body corporate is wound up;
 - (c) the person resigns from the Association under rule 12;
 - (d) the person is expelled from the Association under rule 17;
 - (e) the person ceases to be a member under rule 14(4).
2. The secretary must keep a record, for at least one year after a person ceases to be a member, of —
 - (a) the date on which the person ceased to be a member; and
 - (b) the reason why the person ceased to be a member.

12. Resignation

1. A member may resign from membership of the Association by giving written notice of the resignation to the secretary.
2. The resignation takes effect —
 - (a) when the secretary receives the notice; or
 - (b) if a later time is stated in the notice, at that later time.
3. A person who has resigned from membership of the Association remains liable for any fees that are owed to the Association (the **owed amount**) at the time of resignation.
4. The owed amount may be recovered by the Association in a court of competent jurisdiction as a debt due to the Association.

13. Rights Not Transferable

The rights of a member are not transferable and end when membership ceases.

Division 2 – Membership Fees

14. Membership Fees

1. The committee must determine the entrance fee (if any) and the annual membership fee (if any) to be paid for membership of the Association.
2. The fees determined under subrule (1) may be different for different classes of membership.
3. A member must pay the annual membership fee to the treasurer, or another person authorised by the committee to accept payments, by the date (the **due date**) determined by the committee.

4. If a member has not paid the annual membership fee within the period of 3 months after the due date, the member ceases to be a member on the expiry of that period.
5. If a person who has ceased to be a member under subrule (4) offers to pay the annual membership fee after the period referred to in that subrule has expired —
 - (a) the committee may, at its discretion, accept that payment; and
 - (b) if the payment is accepted, the person's membership is reinstated from the date the payment is accepted.

Division 3 – Register Of Members

15. Register Of Members

1. The secretary, or another person authorised by the committee, is responsible for the requirements imposed on the Association under section 53 of the Act to maintain the register of members and record in that register any change in the membership of the Association.
2. In addition to the matters referred to in section 53(2) of the Act, the register of members must include the class of membership (if applicable) to which each member belongs and the date on which each member becomes a member.
3. The register of members must be kept at the secretary's place of residence, or at another place determined by the committee.
4. A member who wishes to inspect the register of members must contact the secretary to make the necessary arrangements.
5. If —
 - (a) a member inspecting the register of members wishes to make a copy of, or take an extract from, the register under section 54(2) of the Act; or
 - (b) a member makes a written request under section 56(1) of the Act to be provided with a copy of the register of members,
 - (c) the committee may require the member to provide a statutory declaration setting out the purpose for which the copy or extract is required and declaring that the purpose is connected with the affairs of the Association.

PART 4 – DISCIPLINARY ACTION, DISPUTES AND MEDIATION

Division 1 – Term Used

16. Term Used: Members

In this Part --

member, in relation to a member who is expelled from the Association, includes former member.

Division 2 – Disciplinary Action

17. Suspension Or Expulsion

1. The committee may decide to suspend a member's membership or to expel a member from the Association if —
 - (a) the member contravenes any of these rules; or
 - (b) the member acts detrimentally to the interests of the Association.

2. The secretary must give the member written notice of the proposed suspension or expulsion at least 28 days before the committee meeting at which the proposal is to be considered by the committee.
3. The notice given to the member must state —
 - (a) when and where the committee meeting is to be held; and
 - (b) the grounds on which the proposed suspension or expulsion is based; and
 - (c) that the member, or the member's representative, may attend the meeting and will be given a reasonable opportunity to make written or oral (or both written and oral) submissions to the committee about the proposed suspension or expulsion;
4. At the committee meeting, the committee must —
 - (a) give the member, or the member's representative, a reasonable opportunity to make written or oral (or both written and oral) submissions to the committee about the proposed suspension or expulsion; and
 - (b) give due consideration to any submissions so made; and
 - (c) decide —
 - (i) whether or not to suspend the member's membership and, if the decision is to suspend the membership, the period of suspension; or
 - (ii) whether or not to expel the member from the Association.
5. A decision of the committee to suspend the member's membership or to expel the member from the Association takes immediate effect.
6. The committee must give the member written notice of the committee's decision, and the reasons for the decision, within 7 days after the committee meeting at which the decision is made.
7. A member whose membership is suspended or who is expelled from the Association may, within 14 days after receiving notice of the Committee's decision under subrule (6), give written notice to the secretary requesting the appointment of a mediator under rule 23.
8. If notice is given under subrule (7), the member who gives the notice and the committee are the parties to the mediation.

18. Consequences Of Suspension

1. During the period a member's membership is suspended, the member —
 - (a) loses any rights (including voting rights) arising as a result of membership; and
 - (b) is not entitled to a refund, rebate, relief or credit for membership fees paid, or payable, to the Association.
2. When a member's membership is suspended, the secretary must record in the register of members —
 - (a) that the member's membership is suspended; and
 - (b) the date on which the suspension takes effect; and
 - (c) the period of the suspension.
3. When the period of the suspension ends, the secretary must record in the register of members that the member's membership is no longer suspended.

Division 3 – Resolving Disputes

19. Terms Used

In this Division —

grievance procedure means the procedures set out in this Division;

party to a dispute includes a person —

- (a) who is a party to the dispute; and
- (b) who ceases to be a member within 6 months before the dispute has come to the attention of each party to the dispute.

20. Parties To Attempt To Resolve Dispute

The parties to a dispute must attempt to resolve the dispute between themselves within 14 days after the dispute has come to the attention of each party.

21. How Grievance Procedure Is Started

1. If the parties to a dispute are unable to resolve the dispute between themselves within the time required by rule 20, any party to the dispute may start the grievance procedure by giving written notice to the secretary of —
 - (a) the parties to the dispute; and
 - (b) the matters that are the subject of the dispute.
2. Within 28 days after the secretary is given the notice, a committee meeting must be convened to consider and determine the dispute.
3. The secretary must give each party to the dispute written notice of the committee meeting at which the dispute is to be considered and determined at least 7 days before the meeting is held.
4. The notice given to each party to the dispute must state —
 - (a) when and where the committee meeting is to be held; and
 - (b) that the party, or the party's representative, may attend the meeting and will be given a reasonable opportunity to make written or oral (or both written and oral) submissions to the committee about the dispute.
5. If —
 - (a) the dispute is between one or more members and the Association; and
 - (b) any party to the dispute gives written notice to the secretary stating that the party —
 - (i) does not agree to the dispute being determined by the committee; and
 - (ii) requests the appointment of a mediator under rule 24,

the committee must not determine the dispute.

22. Determination Of Dispute By Committee

1. At the committee meeting at which a dispute is to be considered and determined, the committee must —

- (a) give each party to the dispute, or the party's representative, a reasonable opportunity to make written or oral (or both written and oral) submissions to the committee about the dispute; and
 - (b) give due consideration to any submissions so made; and
 - (c) determine the dispute.
2. The committee must give each party to the dispute written notice of the committee's determination, and the reasons for the determination, within 7 days after the committee meeting at which the determination is made.
3. A party to the dispute may, within 14 days after receiving notice of the committee's determination under subrule (1)(c), give written notice to the secretary requesting the appointment of a mediator under rule 24.
4. If notice is given under subrule (3), each party to the dispute is a party to the mediation.

Division 4 – Mediation

23. Application Of The Division

1. This Division applies if written notice has been given to the secretary requesting the appointment of a mediator —
 - (a) by a member under rule 17(7); or
 - (b) by a party to a dispute under rule 21(5)(b)(ii) or 22(3).
2. If this Division applies, a mediator must be chosen or appointed under rule 25.

24. Appointment Of Mediator

1. The mediator must be a person chosen —
 - (a) if the appointment of a mediator was requested by a member under rule 17(7) — by agreement between the Member and the committee; or
 - (b) if the appointment of a mediator was requested by a party to a dispute under rule 21(5)(b)(ii) or 22(3) — by agreement between the parties to the dispute.
2. If there is no agreement for the purposes of subrule 1) a) or b), then, subject to subrules 3) and 4), the committee must appoint the mediator.
3. The person appointed as mediator by the committee must be a person who acts as a mediator for another not-for-profit body, such as a community legal centre, if the appointment of a mediator was requested by —
 - (a) a member under rule 17(7); or
 - (b) a party to a dispute under rule 21(5)(b)(ii); or
 - (c) a party to a dispute under rule 22(3) and the dispute is between one or more members and the Association.
4. The person appointed as mediator by the committee may be a member or former member of the Association but must not —
 - (a) have a personal interest in the matter that is the subject of the mediation; or
 - (b) be biased in favour of or against any party to the mediation.

RULES OF THE ASSOCIATION

25. Mediation Process

1. The parties to the mediation must attempt in good faith to settle the matter that is the subject of the mediation.
2. Each party to the mediation must give the mediator a written statement of the issues that need to be considered at the mediation at least 5 days before the mediation takes place.
3. In conducting the mediation, the mediator must —
 - (a) give each party to the mediation every opportunity to be heard; and
 - (b) allow each party to the mediation to give due consideration to any written statement given by another party; and
 - (c) ensure that natural justice is given to the parties to the mediation throughout the mediation process.
4. The mediator cannot determine the matter that is the subject of the mediation.
5. The mediation must be confidential, and any information given at the mediation cannot be used in any other proceedings that take place in relation to the matter that is the subject of the mediation.
6. The costs of the mediation are to be paid by the party or parties to the mediation that requested the appointment of the mediator.

26. If Mediation Results In Decision To Suspend Or Expel Being Revoked

If —

- (a) mediation takes place because a member whose membership is suspended or who is expelled from the Association gives notice under rule 17(7); and
- (b) as the result of the mediation, the decision to suspend the member's membership or expel the member is revoked,

that revocation does not affect the validity of any decision made at a committee meeting or general meeting during the period of suspension or expulsion.

PART 5 – COMMITTEE

Division 1 – Powers Of The Committee

27. Committee

1. The committee members are the persons who, as the management committee of the Association, have the power to manage the affairs of the Association.
2. Subject to the Act and these rules, the Association may do all things necessary or convenient for carrying out its objects and purposes, and in particular, may –
 - (a) acquire, hold, deal with, and dispose of any real or personal property; and
 - (b) open and operate bank accounts; and
 - (c) invest its money —
 - (i) as trust funds may be invested under the Trustees Act 1962 Part III; or
 - (ii) in any other manner authorised by the rules of the Association;

and

RULES OF THE ASSOCIATION

- (d) borrow money upon such terms and conditions as the association thinks fit; and
- (e) give such security for the discharge of liabilities incurred by the association as the association thinks fit; and
- (f) appoint agents to transact any business of the Association on its behalf; and
- (g) enter into any other contract it considers necessary or desirable
- (h) act as trustee and accept and hold real and personal property upon trust
- (i) receive and hold any gift of money or property whether subject to any special trust or not for any one or more of the objects of Western Dressage Association of Australia Incorporated;
- (j) determine, collect and recover from Members all subscriptions, fees, levies and other charges from time to time due to the Association;
- (k) make contributions of money or property calculated to further the objects of Western Dressage Association of Australia Incorporated;
- (l) distribute amongst Members such information as it may create or receive for the benefit of its Members;
- (m) make Rules concerning :
 - (i) all matters connected with the conduct of the affairs of the Association, and;
 - (ii) the promotion, organisation, administration, regulation or conduct of Western Dressage competitions, shows or other exhibitions within Australia;
 - (iii) the registration of horses;
 - (iv) the Affiliation of Western Dressage entities;
 - (v) the eligibility and conduct of competitors, the eligibility of competitors and horses;
 - (vi) the conduct and discipline of competitors, Judges and Officials and Members of Western Dressage Association of Australia Incorporated, and;
 - (vii) the appointment and accreditation of Judges and other Officials.
- (n) take such steps by personal or written appeals, public meetings or otherwise as may from time to time be deemed expedient for the purposes of procuring contributions to the funds of Western Dressage Association of Australia Incorporated in the form of donations, annual subscriptions or otherwise
- (o) publish and distribute by any means written or electronic newspapers, periodicals, books or leaflets;
- (p) develop and implement any computer system or software desirable for the promotion of its objects;
- (q) appoint, hire, employ, remove, replace or reinstate employees or contractors for the carrying out of the objects of Western Dressage Association of Australia Incorporated for such consideration as appropriate;
- (r) buy, sell and deal in all kinds of goods and services for Members or invitees to premises owned or controlled by Western Dressage Association of Australia Incorporated;
- (s) subscribe to any charities and to make donations for any public purpose consistent with the Western Dressage Association of Australia Incorporated Objects;
- (t) create, produce, develop, licence and otherwise exploit, use and protect Intellectual Property;
- (u) promote own and operate corporate entities to carry on and conduct the business affairs of Western Dressage Association of Australia Incorporated or calculated to benefit the Association; and for that purpose, to utilise any of the assets of or held on behalf of

the Association;

- (v) enter into arrangements with any government or authority that are incidental or conducive to the attainment of the objects and the exercise of the powers of Western Dressage Association of Australia Incorporated, and to obtain rights, privileges and concessions from such government or authority and carry out, exercise and comply with any such rights, privileges and concessions;
 - (w) take and effect insurance of itself and its members or seek, obtain and in its discretion act on, any professional advice necessary or appropriate; and
 - (x) to do all such other things as are incidental or conducive to the attainment of the Objects or any of them or as authorised by the Constitution
3. The committee must take all reasonable steps to ensure that the Association complies with the Act, these rules and the by-laws (if any).

Division 2 – Composition Of The Committee And Duties Of Members

28. Committee Members

1. The committee members consist of —
 - (a) the office holders of the Association; and
 - (b) at least one (1) but no more than three (3) ordinary committee members.
2. The following are the office holders of the Association —
 - (a) the chairperson;
 - (b) the deputy chairperson;
 - (c) the secretary;
 - (d) the treasurer.
3. A person may be a committee member if the person is —
 - a) an individual who has reached 19 years of age; and
 - b) an ordinary member.
4. A person must not hold 2 or more of the offices mentioned in subrule (2) at the same time.

29. Chairperson

1. It is the duty of the chairperson to consult with the secretary regarding the business to be conducted at each committee meeting and general meeting.
2. The chairperson has the powers and duties relating to convening and presiding at committee meetings and presiding at general meetings provided for in these rules.

30. Deputy Chairperson

1. It is the duty of the deputy chairperson to take over in the event that the chairperson can't serve their duties. They may also be assigned tasks and duties as required by the committee.

31. Secretary

The Secretary has the following duties —

- (a) dealing with the Association's correspondence;

- (b) consulting with the chairperson regarding the business to be conducted at each committee meeting and general meeting;
- (c) preparing the notices required for meetings and for the business to be conducted at meetings;
- (d) unless another member is authorised by the committee to do so, maintaining on behalf of the Association the register of members, and recording in the register any changes in the membership, as required under section 53(1) of the Act;
- (e) maintaining on behalf of the Association an up-to-date copy of these rules, as required under section 35(1) of the Act;
- (f) unless another member is authorised by the committee to do so, maintaining on behalf of the Association a record of committee members and other persons authorised to act on behalf of the Association, as required under section 58(2) of the Act;
- (g) ensuring the safe custody of the books of the Association, other than the financial records, financial statements and financial reports, as applicable to the Association;
- (h) maintaining full and accurate minutes of committee meetings and general meetings;
- (i) carrying out any other duty given to the secretary under these rules or by the committee.

32. Treasurer

The treasurer has the following duties —

- (a) ensuring that any amounts payable to the Association are collected and issuing receipts for those amounts in the Association's name;
- (b) ensuring that any amounts paid to the Association are credited to the appropriate account of the Association, as directed by the committee;
- (c) ensuring that any payments to be made by the Association that have been authorised by the committee or at a general meeting are made on time;
- (d) ensuring that the Association complies with the relevant requirements of Part 5 of the Act;
- (e) ensuring the safe custody of the Association's financial records, financial statements and financial reports, as applicable to the Association;
- (f) if the Association is a tier 1 association, coordinating the preparation of the Association's financial statements before their submission to the Association's annual general meeting;
- (g) if the Association is a tier 2 association or tier 3 association, coordinating the preparation of the Association's financial report before its submission to the Association's annual general meeting;
- (h) providing any assistance required by an auditor or reviewer conducting an audit or review of the Association's financial statements or financial report under Part 5 Division 5 of the Act;
- (i) carrying out any other duty given to the treasurer under these rules or by the committee.

Division 3 – Election Of The Committee Members And Tenure Of Office

33. How Members Become Committee Members

A member becomes a committee member if the member —

- (a) is elected to the committee at a general meeting; or
- (b) is appointed to the committee by the committee to fill a casual vacancy under rule 40.

RULES OF THE ASSOCIATION

34. Nomination Of Committee Members

1. At least 28 days before an annual general meeting, the secretary must send written notice to all the members —
 - (a) calling for nominations for election to the committee; and
 - (b) stating the date by which nominations must be received by the secretary to comply with subrule (2).
2. A member who wishes to be considered for election to the committee as a member under rule 28(1)(a) or 28(1)(b) at the annual general meeting, must nominate for election by sending written notice of the nomination to the secretary at least 10 days before the annual general meeting.
3. The written notice must include a statement by another member in support of the nomination.
4. A nominating member may be required to provide details of experience and skills that will be of benefit to the Association.
5. A member whose nomination does not comply with this rule is not eligible for election to the committee unless the member is nominated under rule 35(2) or 36(2)(b).

35. Election And Appointment Of Office Holders

1. At the annual general meeting, elections must be held separately for any vacant office holder positions of the Association.
2. If there is no nomination for a position, the chairperson of the meeting may call for nominations from the ordinary members at the meeting.
3. If the number of nominations is equal to the number to be elected, the chairperson of the meeting must declare the Members elected to the positions.
4. If the number of nominations exceeds the number to be elected, the ordinary members at the meeting must vote in accordance with procedures that have been determined by the committee to decide who is to be elected to the position.
5. Each ordinary member present at the meeting may vote for one member who has nominated for the position.
6. A member who has nominated for the position may vote for himself or herself.
7. At the first committee meeting following the annual general meeting, the committee shall appoint office holders from amongst their number for these positions by way of a nomination and motion to carry for each position.
 - (a) Chairperson;
 - (b) Deputy Chairperson;
 - (c) Secretary;
 - (d) Treasurer and;
 - (e) Any other positions determined as necessary by the committee

36. Election And Appointment Of Ordinary Committee Members

1. At the annual general meeting, the Association must decide by resolution the number of ordinary committee members (between 1 & 3) to hold office for the next year. Elections must be held separately for any vacant ordinary committee member positions.

RULES OF THE ASSOCIATION

2. If the number of members nominating for the position of ordinary committee member is not greater than the number to be elected, the chairperson of the meeting —
 - (a) must declare each of those members to be elected to the position; and
 - (b) may call for further nominations from the ordinary members at the meeting to fill any positions remaining unfilled after the elections under paragraph (a).
3. If —
 - (a) the number of members nominating for the position of ordinary committee member is greater than the number to be elected; or
 - (b) the number of members nominating under subrule (2)(b) is greater than the number of positions remaining unfilled,

the ordinary members at the meeting must vote in accordance with procedures that have been determined by the committee to decide the members who are to be elected to the position of ordinary committee member.
4. A member who has nominated for the position of ordinary committee member may vote in accordance with that nomination. At the first committee meeting following the annual general meeting, the committee may appoint the duly elected ordinary committee member to a position under rule 35(7)(e).

37. Term Of Office

1. The term of office of a committee member begins when the member —
 - (a) is elected at an annual general meeting or under subrule 38(3)(b); or
 - (b) is appointed to fill a casual vacancy under rule 40.
2. Subject to rule 39, a committee member holds office for a term of two (2) years, until the position on the committee is declared vacant at the second annual general meeting following their election.
3. A committee member may be re-elected.

38. Resignation And Removal From Office

1. A committee member may resign from the committee by written notice given to the secretary or, if the resigning member is the secretary, given to the chairperson.
2. The resignation takes effect —
 - (a) when the notice is received by the secretary or chairperson; or
 - (b) if a later time is stated in the notice, at the later time.
3. At a general meeting, the Association may by resolution —
 - (a) remove a committee member from office; and
 - (b) elect a member who is eligible under rule 28(3) to fill the vacant position.
4. A committee member who is the subject of a proposed resolution under subrule (3)(a) may make written representations (of a reasonable length) to the secretary or chairperson and may ask that the representations be provided to the members.
5. The secretary or chairperson may give a copy of the representations to each member or, if they are not so given, the committee member may require them to be read out at the general meeting at which the resolution is to be considered.

RULES OF THE ASSOCIATION

39. When Membership Of Committee Ceases

1. A person ceases to be a committee member if the person —
 - (a) dies or otherwise ceases to be a member; or
 - (b) resigns from the committee or is removed from office under rule 38; or
 - (c) becomes ineligible to accept an appointment or act as a committee member under section 39 of the Act;
 - (d) becomes permanently unable to act as a committee member because of a mental or physical disability; or
 - (e) fails to attend three (3) Committee meetings, of which the person has been given notice, without having notified the Committee that the person will be unable to attend.
2. In accordance with section 41 of the Act, where a person ceases to be a member of the committee, that person is required to, as soon as reasonably practicable after their membership ceases, deliver to a member of the committee all of the relevant documents and records they hold pertaining to the management of the association's affairs.

40. Filling Casual Vacancies

1. The committee may appoint a member who is eligible under rule 28(3) to fill a position on the committee that —
 - (a) has become vacant under rule 39; or
 - (b) was not filled by election at the most recent annual general meeting or under rule 38(3)(b).
2. If the position of secretary becomes vacant, the committee must appoint a member who is eligible under rule 28(3) to fill the position within 14 days after the vacancy arises.
3. Subject to the requirement for a quorum under rule 47, the committee may continue to act despite any vacancy in its membership.
4. If there are fewer committee members than required for a quorum under rule 47, the committee may act only for the purpose of —
 - (a) appointing committee members under this rule; or
 - (b) convening a general meeting.

41. Validity Of Acts

The acts of a committee or subcommittee, or of a committee member or member of a subcommittee, are valid despite any defect that may afterwards be discovered in the election, appointment or qualification of a committee member or member of a subcommittee.

42. Payments To Committee Members

1. In this rule —
 - committee member** includes a member of a subcommittee;
 - committee meeting** includes a meeting of a subcommittee.
2. A committee member is entitled to be paid out of the funds of the Association for any out-of-pocket expenses for travel and accommodation properly incurred —
 - (a) in attending a committee meeting or
 - (b) in attending a general meeting; or

RULES OF THE ASSOCIATION

- (c) otherwise in connection with the Association's business.

Division 4 –Committee Meetings

43. Committee Meetings

1. The committee must meet at least 6 times in each year on the dates and at the times and places determined by the committee.
2. The date, time and place of the first committee meeting must be determined by the committee members as soon as practicable after the annual general meeting at which the committee members are elected.
3. Special committee meetings may be convened by the chairperson or any 2 committee members.

44. Notice Of Committee Meetings

1. Notice of each committee meeting must be given to each committee member at least 48 hours before the time of the meeting.
2. The notice must state the date, time and place of the meeting and must describe the general nature of the business to be conducted at the meeting.
3. Unless subrule (4) applies, the only business that may be conducted at the meeting is the business described in the notice.
4. Urgent business that has not been described in the notice may be conducted at the meeting if the committee members at the meeting unanimously agree to treat that business as urgent.

45. Procedure And Order Of Business

1. The chairperson or, in the chairperson's absence, the deputy-chairperson must preside as chairperson of each committee meeting.
2. If the chairperson and deputy chairperson are absent or are unwilling to act as chairperson of a meeting, the committee members at the meeting must choose one of them to act as chairperson of the meeting.
3. The procedure to be followed at a committee meeting must be determined from time to time by the committee.
4. The order of business at a committee meeting may be determined by the committee members at the meeting.
5. A member or other person who is not a committee member may attend a committee meeting if invited to do so by the committee.
6. A person invited under subrule (5) to attend a committee meeting —
 - (a) has no right to any agenda, minutes or other document circulated at the meeting; and
 - (b) must not comment about any matter discussed at the meeting unless invited by the committee to do so; and
 - (c) cannot vote on any matter that is to be decided at the meeting.

RULES OF THE ASSOCIATION

46. Use Of Technology To Be Present At Committee Meetings

1. The presence of a committee member at a committee meeting need not be by attendance in person but may be by that committee member and each other committee member at the meeting being simultaneously in contact by telephone or other means of instantaneous communication.

2. A member who participates in a committee meeting as allowed under subrule (1) is taken to be present at the meeting and, if the member votes at the meeting, the member is taken to have voted in person.

47. Quorum For Committee Meetings

1. Subject to rule 40(4), no business is to be conducted at a committee meeting unless a quorum is present. Any four (4) committee members constitute a quorum for the conduct of the business of a committee meeting.

2. If a quorum is not present within 30 minutes after the notified commencement time of a committee meeting —

(a) in the case of a special meeting — the meeting lapses; or

(b) otherwise, the meeting is adjourned to the same time, day and place in the following week.

3. If —

(a) a quorum is not present within 30 minutes after the commencement time of a committee meeting held under subrule (2)(b); and

(b) at least 2 committee members are present at the meeting,

those members present are taken to constitute a quorum.

48. Voting At Committee Meetings

1. Each committee member present at a committee meeting has one vote on any question arising at the meeting.

2. A motion is carried if a majority of the committee members present at the committee meeting vote in favour of the motion.

3. If the votes are divided equally on a question, the chairperson of the meeting has a second or casting vote.

4. A vote may take place by the committee members present indicating their agreement or disagreement or by a show of hands, unless the committee decides that a secret ballot is needed to determine a particular question.

5. If a secret ballot is needed, the chairperson of the meeting must decide how the ballot is to be conducted.

49. Minutes Of Committee Meetings

1. The committee must ensure that minutes are taken and kept of each committee meeting.

2. The minutes must record the following —

(a) the names of the committee members present at the meeting;

(b) the name of any person attending the meeting under rule 45(5);

(c) the business considered at the meeting;

(d) any motion on which a vote is taken at the meeting and the result of the vote.

RULES OF THE ASSOCIATION

3. The minutes of a committee meeting must be entered in the Association's minute book within 30 days after the meeting is held.
4. The committee at the following committee meeting are to review the minutes and carry a motion to accept the minutes as correct.
5. When the motion has been carried to accept minutes of a committee meeting as correct, they are, until the contrary is proved, evidence that —
 - (a) the meeting to which the minutes relate was duly convened and held; and
 - (b) the matters recorded as having taken place at the meeting took place as recorded; and
 - (c) any appointment purportedly made at the meeting was validly made.

Division 5 –Subcommittees And Subsidiary Offices

50. Subcommittees And Subsidiary Offices

1. To help the committee in the conduct of the Association's business, the committee may, in writing, do either or both of the following —
 - (a) appoint one or more subcommittees;
 - (b) create one or more subsidiary offices and appoint people to those offices.
2. A subcommittee may consist of the number of people, whether or not members, that the committee considers appropriate.
3. A person may be appointed to a subsidiary office whether or not the person is a member.
4. Subject to any directions given by the committee —
 - (a) a subcommittee may meet and conduct business as it considers appropriate; and
 - (b) the holder of a subsidiary office may carry out the functions given to the holder as the holder considers appropriate.

51. Delegation To Subcommittees And Holders Of Subsidiary Offices

1. In this rule —

non-delegable duty means a duty imposed on the committee by the Act or another written law.
2. The committee may, in writing, delegate to a subcommittee or the holder of a subsidiary office the exercise of any power or the performance of any duty of the committee other than —
 - (a) the power to delegate; and
 - (b) a non-delegable duty.
3. A power or duty, the exercise or performance of which has been delegated to a subcommittee or the holder of a subsidiary office under this rule, may be exercised or performed by the subcommittee or holder in accordance with the terms of the delegation.
4. The delegation may be made subject to any conditions, qualifications, limitations or exceptions that the committee specifies in the document by which the delegation is made.
5. The delegation does not prevent the committee from exercising or performing at any time the power or duty delegated.
6. Any act or thing done by a subcommittee or by the holder of a subsidiary office, under the delegation has the same force and effect as if it had been done by the committee.
7. The committee may, in writing, amend or revoke the delegation.

RULES OF THE ASSOCIATION

PART 6 – GENERAL MEETINGS OF ASSOCIATION

52. Annual General Meeting

1. The committee must determine the date, time and place of the annual general meeting.
2. If it is proposed to hold the annual general meeting more than 6 months after the end of the Association's financial year, the secretary must apply to the Commissioner for permission under section 50(3)(b) of the Act within 4 months after the end of the financial year.
3. The ordinary business of the annual general meeting is as follows —
 - (a) to confirm the minutes of the previous annual general meeting and of any special general meeting held since then if the minutes of that meeting have not yet been confirmed;
 - (b) to receive and consider —
 - (i) the committee's annual report on the Association's activities during the preceding financial year; and
 - (ii) if the Association is a tier 1 association, the financial statements of the Association for the preceding financial year presented under Part 5 of the Act; and
 - (iii) if the Association is a tier 2 association or a tier 3 association, the financial report of the Association for the preceding financial year presented under Part 5 of the Act;
 - (iv) if required to be presented for consideration under Part 5 of the Act, a copy of the report of the review or auditor's report on the financial statements or financial report;
 - (c) to elect the office holders of the Association and other committee members;
 - (d) if applicable, to appoint or remove a reviewer or auditor of the Association in accordance with the Act;
 - (e) to confirm or vary the entrance fees, subscriptions and other amounts (if any) to be paid by members.
4. Any other business of which notice has been given in accordance with these rules may be conducted at the annual general meeting.

53. Special General Meetings

1. The committee may convene a special general meeting.
2. The committee must convene a special general meeting if at least 20% of the members require a special general meeting to be convened.
3. The members requiring a special general meeting to be convened must —
 - (a) make the requirement by written notice given to the secretary; and
 - (b) state in the notice the business to be considered at the meeting; and
 - (c) each sign the notice.
4. The special general meeting must be convened within 28 days after notice is given under subrule (3)(a).
5. If the committee does not convene a special general meeting within that 28 day period, the members making the requirement (or any of them) may convene the special general meeting.
6. A special general meeting convened by members under subrule (5) —
 - (a) must be held within 3 months after the date the original requirement was made; and

RULES OF THE ASSOCIATION

- (b) may only consider the business stated in the notice by which the requirement was made.
- 7. The Association must reimburse any reasonable expenses incurred by the members convening a special general meeting under subrule (5).

54. Notice Of General Meetings

- (1) The secretary or, in the case of a special general meeting convened under rule 53(5), the members convening the meeting, must give to each member —
 - (a) at least 21 days' notice of a general meeting if a special resolution is to be proposed at the meeting; or
 - (b) at least 14 days' notice of a general meeting in any other case.
- (2) The notice must —
 - (a) specify the date, time and place of the meeting; and
 - (b) indicate the general nature of each item of business to be considered at the meeting; and
 - (c) if a special resolution is proposed —
 - (i) set out the wording of the proposed resolution as required by section 51(4) of the Act; and
 - (ii) state that the resolution is intended to be proposed as a special resolution; and
 - (iii) comply with rule 55(7).

55. Proxies

- 1. Subject to subrule (2), an ordinary member may appoint an individual who is an ordinary member as his or her proxy to vote and speak on his or her behalf at a general meeting.
- 2. An ordinary member may be appointed the proxy for not more than 5 other members.
- 3. The appointment of a proxy must be in writing and signed by the member making the appointment.
- 4. The member appointing the proxy may give specific directions as to how the proxy is to vote on his or her behalf.
- 5. If no instructions are given to the proxy, the proxy may vote on behalf of the member in any matter as the proxy sees fit.
- 6. If the committee has approved a form for the appointment of a proxy, the member may use that form or any other form —
 - (a) that clearly identifies the person appointed as the member's proxy; and
 - (b) that has been signed by the member.
- 7. Notice of a general meeting given to an ordinary member under rule 54 must —
 - (a) state that the member may appoint an individual who is an ordinary member as a proxy for the meeting; and
 - (b) include a copy of any form that the committee has approved for the appointment of a proxy.
- 8. A form appointing a proxy must be given to the secretary before the commencement of the general meeting for which the proxy is appointed.
- 9. A form appointing a proxy sent by post or electronically is of no effect unless it is received by the Association not later than 24 hours before the commencement of the meeting.

RULES OF THE ASSOCIATION

56. Use Of Technology To Be Present At General Meetings

- (1) The presence of a member at a general meeting need not be by attendance in person but may be by that member and each other member at the meeting being simultaneously in contact by telephone or other means of instantaneous communication.
- (2) A member who participates in a general meeting as allowed under subrule (1) is taken to be present at the meeting and, if the member votes at the meeting, the member is taken to have voted in person.

57. Presiding Member And Quorum For General Meetings

- (1) The chairperson or, in the chairperson's absence, the deputy chairperson must preside as chairperson of each general meeting.
- (2) If the chairperson and deputy chairperson are absent or are unwilling to act as chairperson of a general meeting, the committee members at the meeting must choose one of them to act as chairperson of the meeting.
- (3) No business is to be conducted at a general meeting unless a quorum is present. Any ten (10) members personally present, being members entitled to vote under these rules at a general meeting, will constitute a quorum for the conduct of business at a general meeting.
- (4) If a quorum is not present within 30 minutes after the notified commencement time of a general meeting —
 - (a) in the case of a special general meeting — the meeting lapses; or
 - (b) in the case of the annual general meeting — the meeting is adjourned to —
 - (i) the same time and day in the following week; and
 - (ii) the same place, unless the chairperson specifies another place at the time of the adjournment or written notice of another place is given to the members before the day to which the meeting is adjourned.
- (5) If —
 - (a) a quorum is not present within 30 minutes after the commencement time of an annual general meeting held under subrule (4)(b); and
 - (b) at least 2 ordinary members are present at the meeting,

those members present are taken to constitute a quorum.

58. Adjournment Of General Meeting

1. The chairperson of a general meeting at which a quorum is present may, with the consent of a majority of the ordinary members present at the meeting, adjourn the meeting to another time at the same place or at another place.
2. Without limiting subrule (1), a meeting may be adjourned —
 - (a) if there is insufficient time to deal with the business at hand; or
 - (b) to give the members more time to consider an item of business.
3. No business may be conducted on the resumption of an adjourned meeting other than the business that remained unfinished when the meeting was adjourned.

RULES OF THE ASSOCIATION

4. Notice of the adjournment of a meeting under this rule is not required unless the meeting is adjourned for 14 days or more, in which case notice of the meeting must be given in accordance with rule 54.

59. Voting At General Meeting

- (1) On any question arising at a general meeting —
 - (a) subject to subrule (6), each ordinary member has one vote unless the member may also vote on behalf of a body corporate under subrule (2); and
 - (b) ordinary members may vote personally or by proxy.
- (2) An ordinary member that is a body corporate may, in writing, appoint an individual, whether or not the individual is a member, to vote on behalf of the body corporate on any question at a particular general meeting or at any general meeting, as specified in the document by which the appointment is made.
- (3) A copy of the document by which the appointment is made must be given to the secretary before any general meeting to which the appointment applies.
- (4) The appointment has effect until —
 - (a) the end of any general meeting to which the appointment applies; or
 - (b) the appointment is revoked by the body corporate and written notice of the revocation is given to the secretary.
- (5) Except in the case of a special resolution, a motion is carried if a majority of the ordinary members present at a general meeting vote in favour of the motion.
- (6) If votes are divided equally on a question, the chairperson of the meeting has a second or casting vote.
- (7) If the question is whether or not to confirm the minutes of a previous general meeting, only members who were present at that meeting may vote.
- (8) For a person to be eligible to vote at a general meeting as an ordinary member, or on behalf of an ordinary member that is a body corporate under subrule (2), the ordinary member —
 - (a) must have been an ordinary member at the time notice of the meeting was given under rule 54; and
 - (b) must have paid any fee or other money payable to the Association by the member.

60. When Special Resolutions Are Required

- (1) A special resolution is required if it is proposed at a general meeting —
 - (a) to affiliate the Association with another body; or
 - (b) to request the Commissioner to apply to the State Administrative Tribunal under section 109 of the Act for the appointment of a statutory manager; or
 - (c) to alter its rules, including changing the name of the association; or
 - (d) to decide to apply for registration or incorporation as a prescribed body corporate in accordance with section 93(1) of the Act; or
 - (e) to approve the terms of an amalgamation with one or more other incorporated associations; or
 - (f) to be wound up voluntarily or by the Supreme Court; or
 - (g) to cancel its incorporation.

RULES OF THE ASSOCIATION

- (2) Subrule (1) does not limit the matters in relation to which a special resolution may be proposed.

61. Determining Whether Resolution Carried

1. In this rule —
poll means the process of voting in relation to a matter that is conducted in writing.
2. Subject to subrule (4), the chairperson of a general meeting may, on the basis of general agreement or disagreement or by a show of hands, declare that a resolution has been —
 - (a) carried; or
 - (b) carried unanimously; or
 - (c) carried by a particular majority; or
 - (d) lost.
3. If the resolution is a special resolution, the declaration under subrule (2) must identify the resolution as a special resolution.
4. If a poll is demanded on any question by the chairperson of the meeting or by at least 3 other ordinary members present in person or by proxy —
 - (a) the poll must be taken at the meeting in the manner determined by the chairperson;
 - (b) the chairperson must declare the determination of the resolution on the basis of the poll.
5. If a poll is demanded on the election of the chairperson or on a question of an adjournment, the poll must be taken immediately.
6. If a poll is demanded on any other question, the poll must be taken before the close of the meeting at a time determined by the chairperson.
7. A declaration under subrule (2) or (4) must be entered in the minutes of the meeting, and the entry is, without proof of the voting in relation to the resolution, evidence of how the resolution was determined.

62. Minutes Of General Meeting

1. The secretary, or a person authorised by the committee from time to time, must take and keep minutes of each general meeting.
2. The minutes must record the business considered at the meeting, any resolution on which a vote is taken and the result of the vote.
3. In addition, the minutes of each annual general meeting must record —
 - (a) the names of the ordinary members attending the meeting; and
 - (b) any proxy forms given to the chairperson of the meeting under rule 55(8); and
 - (c) the financial statements or financial report presented at the meeting, as referred to in rule 52(3)(b)(ii) or (iii); and
 - (d) any report of the review or auditor's report on the financial statements or financial report presented at the meeting, as referred to in rule 52(3)(b)(iv).
4. The minutes of a general meeting must be entered in the Association's minute book within 30 days after the meeting is held.
5. The chairperson at the next general meeting must ensure that the minutes of the previous general meeting are reviewed and must move a motion to accept the minutes as correct.

RULES OF THE ASSOCIATION

6. When a motion has been carried to accept the minutes of a general meeting as correct, they are, in the absence of evidence to the contrary, taken to be proof that —
 - (a) the meeting to which the minutes relate was duly convened and held; and
 - (b) the matters recorded as having taken place at the meeting took place as recorded; and
 - (c) any election or appointment purportedly made at the meeting was validly made.

PART 7 – FINANCIAL MATTERS

63. Source Of Funds

The funds of the Association may be derived from entrance fees, annual subscriptions, donations, fund-raising activities, grants, interest and any other sources approved by the committee.

64. Control Of Funds

1. The Association must open an account in the name of the Association with a financial institution from which all expenditure of the Association is made and into which all funds received by the Association are deposited.
2. Subject to any restrictions imposed at a general meeting, the committee may approve expenditure on behalf of the Association.
3. The committee may authorise the treasurer to expend funds on behalf of the Association up to a specified limit without requiring approval from the committee for each item on which the funds are expended.
4. All cheques, drafts, bills of exchange, promissory notes and other negotiable instruments of the Association must be signed by —
 - (a) 2 committee members; or
 - (b) one committee member and a person authorised by the committee.
5. All funds of the Association must be deposited into the Association's account within 5 working days after their receipt.

65. Financial Statements And Financial Reports

1. For each financial year, the committee must ensure that the requirements imposed on the Association under Part 5 of the Act relating to the financial statements or financial report of the Association are met.
2. Without limiting subrule (1), those requirements include —
 - (a) if the Association is a tier 1 association, the preparation of the financial statements; and
 - (b) if the Association is a tier 2 association or tier 3 association, the preparation of the financial report; and
 - (c) if required, the review or auditing of the financial statements or financial report, as applicable; and
 - (d) the presentation to the annual general meeting of the financial statements or financial report, as applicable; and
 - (e) if required, the presentation to the annual general meeting of the copy of the report of the review or auditor's report, as applicable, on the financial statements or financial report.

RULES OF THE ASSOCIATION

PART 8 – GENERAL MATTERS

66. By-laws

1. The Association may, by resolution at a general meeting, make, amend or revoke by-laws.
2. By-laws may —
 - (a) provide for the rights and obligations that apply to any classes of additional membership approved under rule 9(2); and
 - (b) impose restrictions on the committee's powers, including the power to dispose of the association's assets; and
 - (c) impose requirements relating to the financial reporting and financial accountability of the association and the auditing of the association's accounts; and
 - (d) provide for any other matter the association considers necessary or convenient to be dealt with in the by-laws.
3. A by-law is of no effect to the extent that it is inconsistent with the Act, the regulations or these rules.
4. Without limiting subrule (3), a by-law made for the purposes of subrule (2)(c) may only impose requirements on the Association that are additional to, and do not restrict, a requirement imposed on the Association under Part 5 of the Act.
5. At the request of a member, the Association must make a copy of the by-laws available for inspection by the member.

67. Executing Documents And Common Seal

1. The Association may execute a document without using a common seal if the document is signed by —
 - (a) 2 committee members; or
 - (b) one committee member and a person authorised by the committee.
2. If the Association has a common seal —
 - (a) the name of the Association must appear in legible characters on the common seal; and
 - (b) a document may only be sealed with the common seal by the authority of the committee and in the presence of —
 - (i) 2 committee members; or
 - (ii) one committee member and a person authorised by the committee,and each of them is to sign the document to attest that the document was sealed in their presence.
3. The secretary must make a written record of each use of the common seal.
4. The common seal must be kept in the custody of the secretary or another committee member authorised by the committee.

68. Giving Notices To Members

1. In this rule —

recorded means recorded in the register of members.
2. A notice or other document that is to be given to a member under these rules is taken not to have been given to the member unless it is in writing and —

- (a) delivered by hand to the recorded address of the member; or
- (b) sent by prepaid post to the recorded postal address of the member; or
- (c) sent by facsimile or electronic transmission to an appropriate recorded number or recorded electronic address of the member.

69. Custody Of Books And Securities

1. Subject to subrule (2), the books and any securities of the Association must be kept in the secretary's custody or under the secretary's control.
2. The financial records and, as applicable, the financial statements or financial reports of the Association must be kept in the treasurer's custody or under the treasurer's control.
3. Subrules (1) and (2) have effect except as otherwise decided by the committee.
4. The books of the Association must be retained for at least 7 years.

70. Record Of Office Holders

The record of committee members and other persons authorised to act on behalf of the Association that is required to be maintained under section 58(2) of the Act must be kept in the secretary's custody or under the secretary's control.

71. Inspection Of Records And Documents

1. Subrule (2) applies to a member who wants to inspect —
 - (a) the register of members under section 54(1) of the Act; or
 - (b) the record of the names and addresses of committee members, and other persons authorised to act on behalf of the Association, under section 58(3) of the Act; or
 - (c) any other record or document of the association.
2. The member must contact the secretary to make the necessary arrangements for the inspection.
3. The inspection must be free of charge.
4. If the member wants to inspect a document that records the minutes of a committee meeting, the right to inspect that document is subject to any decision the committee has made about minutes of committee meetings generally, or the minutes of a specific committee meeting, being available for inspection by members.
5. The member may make a copy of or take an extract from a record or document referred to in subrule (1)(c) but does not have a right to remove the record or document for that purpose.
6. The member must not use or disclose information in a record or document referred to in subrule (1)(c) except for a purpose —
 - (a) that is directly connected with the affairs of the Association; or
 - (b) that is related to complying with a requirement of the Act.

72. Publication By Committee Members Of Statements About Association Business Prohibited

A committee member must not publish, or cause to be published, any statement about the business conducted by the Association at a general meeting or committee meeting unless —

- (a) the committee member has been authorised to do so at a committee meeting; and
- (b) the authority given to the committee member has been recorded in the minutes of the committee meeting at which it was given.

73. Distribution Of Surplus Property On Cancellation Of Incorporation Or Winding Up

1. In this rule —

surplus property, in relation to the Association, means property remaining after satisfaction of —

- (a) the debts and liabilities of the Association; and
- (b) the costs, charges and expenses of winding up or cancelling the incorporation of the Association,

but does not include books relating to the management of the Association.

2. On the cancellation of the incorporation or the winding up of the Association, its surplus property must be distributed as determined by special resolution by reference to the persons mentioned in section 24(1) of the Act.

74. Alteration Of Rules

If the Association wants to alter or rescind any of these rules, or to make additional rules, the Association may do so only by special resolution and by otherwise complying with Part 3 Division 2 of the Act.
